AFFILIATE MEMBERSHIP DUES INFORMATION

\$150 Annual Dues amount for Primary Affiliate membership in the Paul Bunyan Board of REALTORS®

\$25 Annual Dues amount for Secondary Affiliate membership for those who wish membership participation and are employed in the same location. They will join under the membership of the firm's Primary Representative. Secondary Affiliate Membership dues are not prorated, and will be \$25 at any time during the year.

ADDITIONAL INFORMATION:
